#### QUIZ NIGHT «HUMAN RIGHTS FOR ALL» FOR SCHOLARS IN BISHKEK AND MAEVKA VILLAGE

Schoolchildren of Bishkek city and Maevka village will improve their knowledge about the protection of rights and equality by taking part in the intellectual game "Human Rights for All". On 27 November 2023, at 13:00, an intellectual Quiz game dedicated to the 75th anniversary of the Universal Declaration of Human Rights and the upcoming XVII International Documentary Film Festival "Bir Duino Kyrgyzstan" will take place.

The purpose of the event "Human Rights for All" is to engage schoolchildren in an educational and interactive process highlighting the foundations of the Universal Declaration of Human Rights. The event is aimed at strengthening awareness and active participation of young people in the protection of human rights through a combination of an educational element and cinema.



PU "Center for the protection of children" (CPC) is a non-governmental organization with extensive (more than 20 years) experience in social work with children of internal migrants in difficult life situations (street children, working children; children facing various types of violence; children who have dropped out of school or who are not able to attend school due to difficult situations in families, and other children in DLS). Carrying out activities for the revitalization and social mobilization of families in DLS and internal migrant families resided in the new settlements around Bishkek, the organization involves the most active representatives of its target groups (children, parents, community activists) in solving problems at school, community, local and national levels; organizes discussion platforms involving all stakeholders to discuss problems and sensitive issues; and provides the active representatives of the target groups with support in assessing needs and conducting advocacy campaigns. The advocacy campaigns can often target not only local authorities, but also the state bodies at different levels and the Parliament of the Kyrgyz Republic.

### TRAINING FOR LAWYERS ON HANDLING CASES OF SEXUALIZED VIOLENCE

This training is designed to expand the knowledge of Kyrgyz lawyers working or starting to work on cases of sexualized violence against women and girls, so that they can protect victims more effectively.

We hope that as a result of the training, participants will get an idea of crimes related to sexualized violence, international standards in this area, national legislation and law enforcement practice, master interview strategies taking into account the interests of victims, learn to recognize myths and stereotypes related to sexualized violence and fight them, understand the specifics of the situation of vulnerable victims and learn how to conduct proceedings taking into account the interests of victims and specific conditions.
