#### Main Activities:

- Preparation of reports and recommendations on improving the situation of the rights of labor migrants with particular focus on women and children;
- Carrying out advocacy and lobbying on national and international levels including OSCE sites and UN Committees;
- Assisting in finding partners, donors and involving partners on Platform into the joint research, trainings and meetings.

#### In the concluding comments were identified our and partners' recommendations to Kyrgyz Republic:

- CMW - 10 recommendations (compliance of KR legislature with international legislature, access to information of labor migrants, predeparture preparation, access to education of their children, equal rights, effective protection, non-discrimination, etc.;

- CESCR- 5 recommendations ( access of labor migrants to services, conclusion of bilateral agreements with the aim of protecting migrants, their children and spouses having a residence permit, to reject the law on «Foreign Agents»;

- To CMW and CESCR on the Republic of Kazakhstan – about 10 recommendations (protection, prevention of trafficking, protection of witnesses, prevention of corruption, monitoring the work conditions, protection and access to services)

#### **Conducting research and preparing reports on the situation with the rights of migrant workers**

In 2016 FIDH together with "Bir Duino Kyrgyzstan" and "Memorial", with the active participation of PF "Mehr Shavkat" conducted a study on the situation with the rights of women and children from Kyrgyzstan involved in migration.

Coverage: Kyrgyzstan, Kazakhstan, Russian Federation. The study was conducted in March – April, 2016. Experts and leadersmembers of the Platform, more than 80 people, took an active part in the study and surveys.

#### Two reports were published as a result:

- «Women and children from Kyrgyzstan involved into migration»
- «Labor migrants in Kazakhstan:without status and rights»

#### Report «Women and children from Kyrgyzstan involved into migration»

The report is based on interviews:

- With 34 women-migrants;
- With migrants' relatives from Kyrgyzstan;
- With representatives of local NGOs that work with sending communities;
- With women and children who became victims of crime;
- With experts on migration issues and gender issues (Bishkek and Osh oblast);
- The report was also based on the evidence of Kyrgyz migrants collected during a research mission in southern Kazakhstan in March, 2016.

#### Report «Labor migrants in Kazakhstan: without status and rights»

Prepared according to the results of the research mission in southern Kazakhstan, as well as on the bas of consultations with stakeholders:

- With human right defenders, representatives of international organizations;
- With state institutions of Kazakhstan;
- With experts on issues of migration with the goal of documenting rights violations of labor migrants and the members of their families.

During regular visits to Kazakhstan between February and May 2016, interviews were conducted with migrants from Kyrgyzstan, Uzbekistan and Tajikistan, and extensive consultations were organized with representatives of civil society in Kazakhstan, as well as a round table in Astana with the participation of experts and representatives of the Kazakh authorities.

In the part about "Tolerance and nondiscrimination", "Economic, social and cultural rights", "Bir Duino Kyrgyzstan" submitted recommendations aimed at protecting the rights of migrant workers.

The recommendations were sent to the Speaker, the fraction leaders, the relevant committees of the Parliament, the President, the Prime Minister, ministries, diplomatic missions, international organizations

### The development of partnership within and outside the Platform

- "Bir Duino Kyrgyzstan" interacted with Caritas France regarding the provision of support for the protection of the rights of migrant workers. In 2016 expert Caritas France assisted in organizing meetings with members of the Platform in Bishkek and in the regions of Kyrgyzstan. At this point, Caritas France and several members of the Platform are implementing project activities
- On the recommendation of Bir Duino Kyrgyzstan, three representatives of the Platform participated in the training "Protection of Fundamental Labor Rights Using International Mechanisms" in Almaty. Experts and members such as Tanya Zorina (Beirut TOT), Baktygul Bazgorpoeva and Nuriya Temirova (Bishkek, TOT), took part in the TOT network of the Women Learning Partnership and Bir Duino Kyrgyzstan on the development of horizontal Leadership. - To develop advocacy campaigns at the level of local communities, national level to promote the rights of migrant workers through effective protection tools.
